**SUBJECT:** GRANT AGREEMENT BETWEEN THE BOROUGH OF COLLINGSWOOD AND THE STATE OF NEW JERSEY BY AND FOR THE DEPARTMENT OF ENVIRONMENTAL PROTECTION


**WHEREAS, THE BOARD OF COMMISSIONERS OF THE BOROUGH OF COLLINGSWOOD DESIRES TO FURTHER THE PUBLIC INTEREST BY OBTAINING A GRANT FROM THE STATE OF NEW JERSEY IN THE AMOUNT OF APPROXIMATELY \$3,000.00 TO FUND THE FOLLOWING PROJECT:**

**COMMUNITY FORESTRY MANAGEMENT PLAN**

**WHEREAS, THE BOARD OF COMMISSIONERS OF THE BOROUGH OF COLLINGSWOOD AUTHORIZES AND HEREBY AGREES TO MATCH 33% OF THE TOTAL PROJECT AMOUNT, IN COMPLIANCE WITH THE MATCH REQUIREMENTS OF THE AGREEMENT. THE AVAILABILITY OF THE MATCH FOR SUCH PURPOSES, WHETHER CASH, SERVICES, OR PROPERTY IS HEREBY CERTIFIED. 75% OF THE MATCH WILL BE MADE UP OF IN-KIND SERVICES (IF ALLOWED BY GRANT PROGRAM REQUIREMENTS AND THE AGREEMENT.)**

**WHEREAS, THE BOARD OF COMMISSIONERS OF THE BOROUGH OF COLLINGSWOOD AGREES TO COMPLY WITH ALL APPLICABLE FEDERAL, STATE, AND MUNICIPAL LAWS, RULES AND REGULATIONS IN ITS PERFORMANCE IN PURSUIT OF THE AGREEMENT.**

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE BOROUGH OF COLLINGSWOOD THAT M. JAMES MALEY, JR. OR THE SUCCESSOR TO THE OFFICE OF MAYOR IS AUTHORIZED (A) TO MAKE APPLICATION FOR SUCH A GRANT (B) IF AWARDED, TO EXECUTE A GRANT AGREEMENT WITH THE STATE FOR A GRANT IN AN AMOUNT NOT LESS THAN \$3,000.00 AND NOT MORE THAN \$3,000.00, AND (C) TO EXECUTE ANY AMENDMENTS THERETO WHICH DO NOT INCREASE THE GRANTEE'S OBLIGATIONS.**
