

ORDINANCE NO: 1435

**AN ORDINANCE AMENDING CHAPTER 217 OF
THE BOROUGH OF COLLINGSWOOD CODE**

BE IT ORDAINED by the Board of Commissioners of the Borough of Collingswood that the Code of the Borough of Collingswood is hereby amended as follows:

I. PURPOSE.

The purpose of this Ordinance is to amend Chapter 217 of the Borough Code titled Parks and to provide for reasonable fees in order to provide funds necessary to maintain playgrounds and recreation places within the Borough. The Borough Commissioners have determined that amending Chapter 217 for this purpose is in the best interest of the Borough's residents.

II AMENDMENTS

1. Change the Heading of Chapter 217 to read PARKS and RECREATION
2. Add a new Article IV to be titled "Department of Recreation"
3. Add a new Section 217-24:

There is hereby created a Department of Recreation for the Borough of Collingswood which shall be supervised by an appointee of the Borough Commissioners. The Department of Recreation shall offer recreational programs for the residents of the Borough of Collingswood and other persons.

4. Add a new Section 217-25 – Recreation Department Fees

The Department of Recreation shall be responsible for organizing and supervising recreational programs within the Borough and shall determine the fees to be charged for such recreational programs. Fees shall be charged to provide the necessary funds for the organization and supervision of the recreational programs and to maintain the playgrounds and recreation places within the Borough. Participation in the following recreation programs of the Department of Recreation shall require payment of the following fees:
